Your firm will be listed in the online edition of the District's Vendor Directory. The directory is located at mwr.org under the "Business with us" tab. Your specialty area will be shown as:


Blueprinting Services; Business Service Centers (except private mail centers); Providing Range of Office Support Services (except printing); Copy Centers (except combined with printing services); Copy Shops (except combined with printing services); Document Copying Services (except combined with printing services); Document Duplicating Services (except combined with printing services); Photocopying Services (except combined with printing services); Reprographic Services; Other Business Service Centers (including Copy Shops)

As a certified MBE, WBE, SBE or VBE, it is your obligation to promptly notify this office in writing of any changes or circumstances that affect your ability to meet ownership, size requirements and/or control of your firm. The notice must take the form of a notarized affidavit sworn to by the owner and provided within 30 days of the change. The District reserves the right to commence actions to revoke your firm's certification if this notification is not made.

Illinois law requires that all corporations secure a Certification of Authority from the Illinois Secretary of State prior to doing business in the State.
